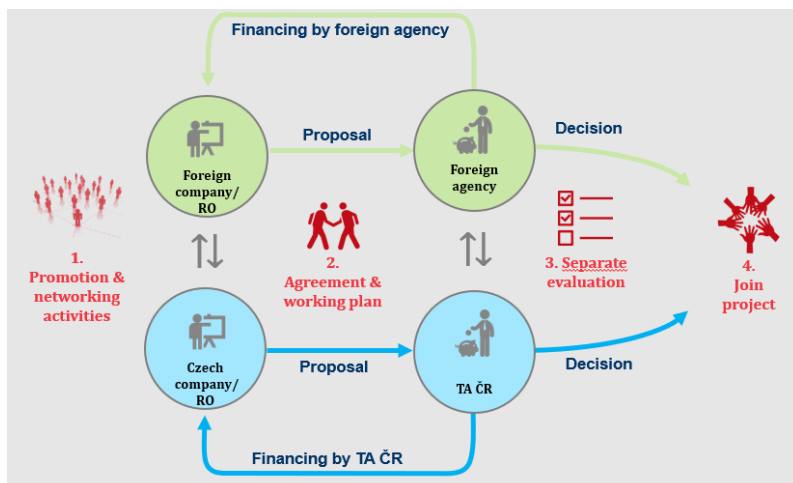


6TH CALL FOR PROPOSALS UNDER DELTA PROGRAMME – GENERAL INFORMATION:

DELTA programme is designed as a funding tool for support of bilateral applied R&D projects. This scheme is complementary to the programmes of the providers in the partnership countries of the Technology Agency of the Czech Republic (TA CR).

Following countries and provinces are included in 6th DELTA call for proposals:

- Republic of Korea
 - Socialist Republic of Vietnam
 - Federal Republic of Germany
 - State of Israel
 - People's Republic of China - Jiangsu Province and Zhejiang Province
 - Republic of China - Taiwan
- At least one applicant on each - Czech and foreign - side has to participate in a joint project. In case of the Czech Republic company has to be a leader of project consortium.
 - Those joint project proposals have to be applied to the competition in both countries by main applicants of both parts of project consortia.
 - Applicants from the Czech Republic apply for the support under DELTA programme - in parallel their foreign partners apply the projects with participation of Czech enterprises (and RO) in their country.
 - Only those projects which are succesfull on both sides could be supported by TA CR.
 - No merge, shared ownership or linkage between Czech and foreign participants is allowed.

 - Programme is not thematically focused. However for some of the partners exact research areas are specified.



Key parameters of 6th DELTA call for proposals:

- Company regardless the size must be the main applicant on the Czech side of project consortium.
- Research organisation from the Czech Republic can apply for the support only when there is a company among the other Czech project participants.
- Projects can last up to 36 months or until 31st December 2021.
- Maximum volume of support per one project on the Czech side is 25 mil. CZK.
- Maximum support rate per Czech project consortium is 74%.
- Following results could be reached:
 - o patent, pilot operation, verified technology, variety, breed, results with legal protection
 - utility model, industrial design, technically realized results - prototype, functional sample, certified methodologies and practices, treatment, conservation methods, specialized maps with expert content, software, other relevant results
- Eligible costs of the 6th DELTA call for proposals are:
 - o personal costs, subcontracting costs, other direct costs (except of stipendia, e.g. intellectual property rights protection costs, depreciation of fixed assets, travel costs, material), indirect (overhead) costs

6th DELTA call for proposals schedule:

1. launch of the call for proposals - 6th June 2018
2. call opened for project proposals - 7th June - 7th August 2018
3. evaluation of project proposals - 8th August - 30th November 2018
4. announcement of the call results - 30th November 2018
5. conclusion of contracts on the provision of funding - November 2018 - January 2019
6. start of projects - 1st December 2018 - 30th June 2019
7. start of funding - January 2019 onwards

Notice: Schedule may vary in partnership countries/provinces.

Significant differences in conditions from the Czech rules:

- PRC - Zhejiang: short overlap in submission period
- Republic of China - Taiwan: limiting criteria on applicants eligibility
- Federal Republic of Germany: 2phase evaluation process and limits on applicant eligibility on Czech side
